Ordering information 19th edition

The book *The Annotated European Patent Convention* is published in English only. It is available in paperback form. Each year a new, updated edition of the book will be published. The 19th edition of the book is updated till 15 November 2011 and is published in December 2011.

The book can be ordered directly from the publisher using the order form overleaf or the editable pdf form on the web site of the publisher (www.htelpublisher.com). Please print the filled in order form, sign it and send it by fax, mail or e-mail.

In general, orders will be despatched within one week from receipt of the order, provided the book is in stock. Delivery in Europe takes about seven days; faster delivery usually takes two to four days, depending on the delivery address. An effort is made to despatch orders received prior to 6 December before 18 December by priority mail.

You can order single copies of the book or you can take a subscription to the annual editions of the book. The termination of the subscription can also be indicated. The desired number of copies can be indicated in the column *Qty*.

Prices include packing and postage to West European countries. They are valid for the 19th edition and apply only when ordering directly from the publisher.

Prices on the order form do not include VAT. The invoice will include 6% VAT for Dutch clients and clients from EU member states without VAT registration number. The invoice will be made up without VAT for clients from outside the EU and for companies within an EU member state other than The Netherlands that have provided their VAT registration number.

Payment should be made only after receipt of the invoice, which will be included in the delivery. Payment shall be made in euro. Please indicate the preferred method of payment on the order form.

- (a) The preferred method is by direct transfer to the bank account of H. Tel using IBAN and BIC codes as stated on the invoice. Please use the EU cross-border transfer with split charges, for which no bank charges are due.
- (b) Payment by PayPal incurs a 5% surcharge. See www.paypal.com.
- (c) Payment by credit card incurs a 10% surcharge. Payment should preferably be made through PayPal, thereby reducing the number of failed payments and decreasing the dissemination of credit card details.

Payment by cheque is not accepted.
