

The table gives the number of the decisions, the date the decision was taken in the form dd.mm.yy, the year and page of publication in the Official Journal of the EPO and references to the sections of the book. Hence, Art.90(3) refers to Article 90(3) EPC, R.46(1):2 refers to note 2 of Rule 46(1) EPC. 'P' refers to the Preamble of the EPC and 'Ante' before a reference refers to the section preceding that reference.
